Minutes of the Ordinary Meeting of the Council held on Thursday 3rd March 2016 in the Church, Paston

Present: N Bardswell, P Clabon, C Emberson, D McKeogh, L Nicholson, E Purdy (Chairman); in attendance: Cllrs W Northam (NCC/NNDC) and B Smith (NNDC); two MODP officers briefly.

- 1. The Chairman welcomed all those present.
- 2. Declarations of interest EP re item 6.2
- 3. The <u>minutes of the Ordinary Meeting of the Council</u> held on January 7th 2016 were approved, and signed, proposer PC, all in favour.

4. Matters arising

- 4.1 <u>NCC Highways matters</u> the Clerk had referred the items form the last meeting to NCC and awaited a reply, particularly about a 30 mph speed limit on the 'coast road', which the Clerk would pass info to Cllr WN. A 'Ranger' visit had been advised for April; the Clerk would refer them to the potholes near the pond at Paston Green.
- 4.2 NNDC, fly tipping this had been reported to NNDC and removed.
- 4.3 <u>Footpaths</u> PC offered to repair and re-site the finger post near the pond for which the Council were grateful.
- 5. Co-option of a member to fill the Council vacancy there was no applicant item deferred.

6. Planning

- 6.1 Mundesley Holiday Village, demolition then 21 holiday lodges (15/1198) the Council had objected to the application and NB had attended the site meeting today. The officer recommendation is for approval and NB would speak for the Council at the Committee.
- 6.2 T Purdy Ltd, conversion to dwelling, Jubilee barn, Edingthorpe Road (15/1577) the Council supported the application.
- 6.3 Mr G Temple, non-material amendment (roof lights) Green Farm House(14/0294) approved.
- 6.4 Mr Mrs A Kerr, detached garage/store, Owl barn, Green Farm Drive (15/1901) the Council had no objection.
- 6.5 Conversion of barn to dwelling, The Old Forge, Mundesley Road (15/1683) the Council had no objection.

8. Playground

- 9.3 To cast the <u>Council's vote a for a AONB representative</u> for the area candidates details had been circulated to Members and the Council agreed to support the five nearest (not Hunstanton). The Clerk would submit the vote.
- 9.4 To consider sending a representative to the <u>Local Coastal Forum at Overstrand</u> (22/3) details had been passed to Members and it was agreed that NB would attend the meeting in Overstrand on March 22nd. The Clerk would advise Overstrand pc.

10. Clerk's and Councillors' Reports

- 10.1 <u>Clerk's report</u> the Clerk advised the Council that the next Coastal Forum is on Tues 8th March at 10am in NNDC's offices at Cromer. He had circulated today's press release about Coastal Defence options to members.
